

Stop Taxpayer Funded Abortion CERTIFIED SIGNATURES PICK UP INSTRUCTIONS

Before you pick up:

- Check the hours of the clerks and make a route so you can get to all of them in the time you have allotted.
- Bring your receipt or print many copies of the authorization letter used for sweeps; you'll need to leave one with each town clerk.

When you pick up:

- Give the Town Clerk your receipt;
- If a sweep, give Town Clerk a copy of your authorization letter and ask for ALL petitions for Stop Taxpayer Funded abortion, including ones you did not drop off.
- Before you leave, check that each paper had been properly time stamped.
- Before you leave, check the back of each page to make sure there are 3 signatures of registrars (usually a stamp, sometimes hand signed), see illustration below.
- Ask for the complete total of all the certified signatures from that town for our petition
- Confirm that the town and county information is filled in
- Email your Regional Director as each town is complete, with the signatures you have in your possession, and the total for that town from the town clerk.

Under Article XLVIII of the Amendments to the Constitution of the Commonwealth

SUMMARY

This proposed law would restore a 2010 vote by the state Board of Elementary and Secondary Education relative to the 2010 Common Core state educational standards. The proposed law would restore the English Language Arts and Mathematics curriculum frameworks in place prior to the vote. The proposed law would require that the Board's process for developing curriculum frameworks include consultations made up of public school teachers and academics from public and private colleges and universities in Massachusetts. It would also require the state Commissioner of Education to copyright the curriculum frameworks and to grant permission to copy any all parts of the frameworks for non-commercial educational purposes. The proposed law would establish three review committees, one for each discipline of math, science and technology, and English. Each committee would be made up of three members from Massachusetts research universities appointed by the Governor. The Board would be prohibited from approving any curriculum frameworks unless the review committees first decide by a two-thirds vote that the frameworks are equivalent to the standards of the most educationally advanced nations as determined by the Trends in Mathematics and Science Study. The proposed law would require that, each year, the Commissioner publicly release all test items, including questions, constructed responses, and essays, for each grade and for every subject. The proposed law states that, if any of its parts were declared invalid, the other parts would stay in effect.

FILING DEADLINES. Initiative petitions must be submitted to local election officials for certification of signatures no later than 5 p.m. on **Wednesday, November 18, 2015.** Local election officials must complete their certification no later than November 30, 2015. Therefore, initiative petitions containing certified signatures must be received by petitioners from the local election officials and then filed with the Elections Division, Office of the Secretary of the Commonwealth, One Ashburton Place, Room 1705, Boston, MA, no later than 5 p.m. on **Wednesday, December 2, 2015.**
